Full customs clearance brokerage

1. Import and Export clearance

Our team will complete your customs declarations as your Direct Representative.

We will work from the Declaron platform and:

- Assist you to set up your product table and customs data on Declaron
- Complete your customs declarations as your Direct Representative
- Complete declarations for all economic procedures such as inward processing, outward processing relief, end use etc. and submission of bills of discharge
- Complete entries for Alcohol and other excisable goods.

You will have access to:

- Your always on portal with your declarations and their status
- Full document retention in your portal together with an audit trail for any future customs queries

This offering is available to importers and exporters with over 10 declarations per month.

If you wish to simplify your import process we can:

- Obtain simplified import authorisations for you
- Assist with the Entry to Records for Entry in the Declarant's Records (EIDR) authorisation holders along with supplemental declarations and end of month reports
- Submit import simplified declarations for authorisation holders along with supplemental declarations and end of month reports.

2. ENS entries

Our team will complete your Entry Summary Declaration (ENS) declarations and Pre-Boarding Notification (PBN) where you have a full load.

3. DAFM and TRACES

If you are an importer of food products we have an add-on specialist service to set you up with Department of Agriculture Food and the Marine (DAFM) and Trade Control and Expert System (TRACES). We will be able to explain and support you with the health cert requirements for your products.

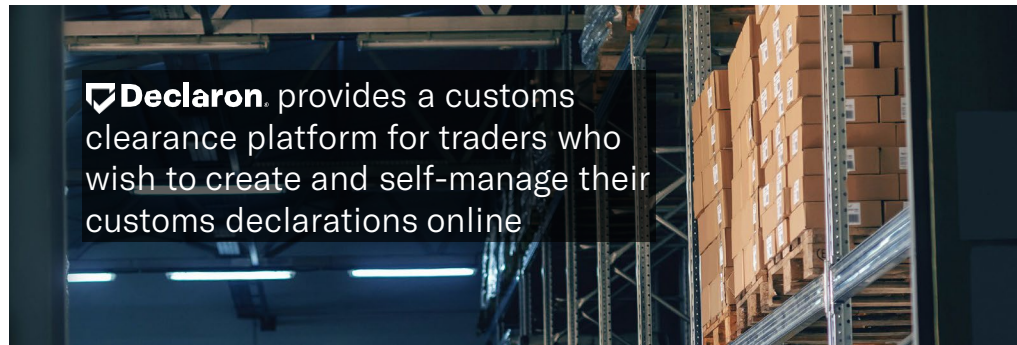
