Introduction

Every month, the HSE releases an update on the prevailing FDR for private & voluntary nursing homes operating under the Fair Deal Scheme across the country. This is the maximum price per week agreed between the nursing home and the HSE under the nursing home support scheme, providing an insight into not only the highest and lowest rates being achieved but also into the changes occurring on a monthly basis for each individual private and voluntary nursing home.

Nursing Homes under the Fair Deal Scheme allow for residents to pay only a portion of their cost of care and the remaining is paid by the HSE to the nursing home.

For the past number of years, our Healthcare Team in Corporate Finance has analysed these changes, noting trends and patterns on a county-by-county basis and an all-country basis. We have now prepared this report to highlight the changes in the rate in the first quarter of 2023.

NTPF weekly rates: Average quarterly % change (December 2022/March 2023)

FDR comparison December '22 vs March '23

This map shows the quarterly average % change in agreed NTPF Fair Deal rates by county in March 2023 compared to the rates in December 2022 of voluntary and private nursing homes:

- The FDR changes are a result of successful negotiation between individual nursing homes and the NTPF to agree on a maximum price that the nursing home charges under the nursing home support scheme on a weekly basis.
- The Country average weekly rate has increased by 1.51% from €1,079 in December 2022 to €1,095 in March 2023.
- 25 counties showed an increase in the weekly average NTPF Fair Deal rates in March compared to December with the highest rate increase of 3.61% in Laois and Longford, where the average rate increased from €1,039 to €1,077 and €987 to €1,023, respectively. The lowest recorded increase of 0.37% was in Roscommon where the average weekly rate increased from €1,001 in December to €1,005 in March.

- 1 county showed no change in average rates compared to December 2022 Fair Deal weekly rates.
- There were three less homes on the scheme during this period. These homes were located in Dublin, Meath, and Waterford.
