



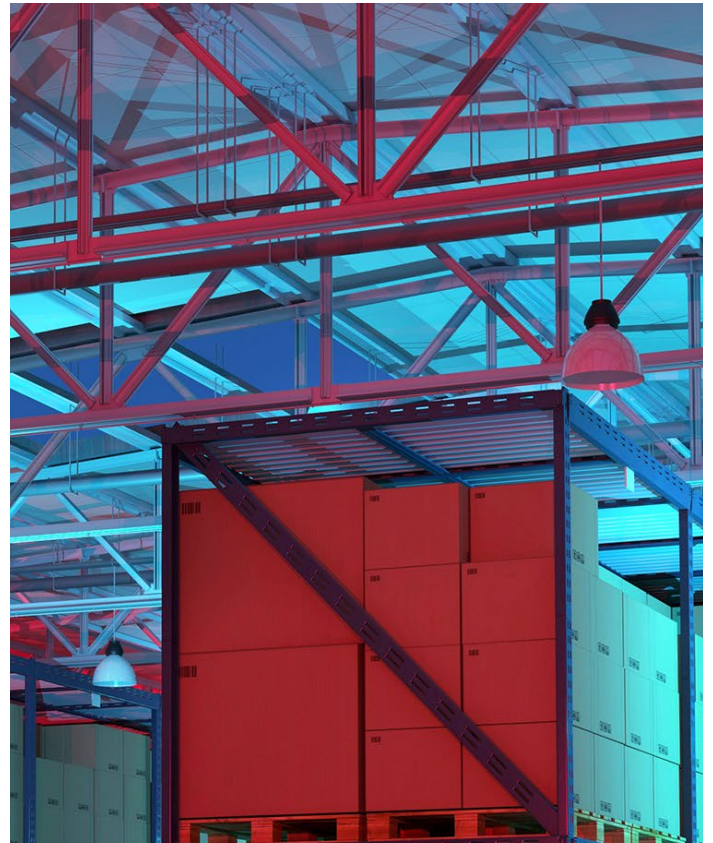
## Authorised Economic Operator (AEO) authorisation

### What is AEO?

AEO stands for Authorised Economic Operator and is an internationally recognised quality mark indicating that your role within the international supply chain is secure and your procedures and customs controls are compliant and efficient.

In order to gain an AEO authorisation the company must fulfil the following criteria:

- ▶ Comply with Customs regulations, have robust procedures covering all elements of Customs requirements
- ▶ Have a satisfactory system of managing commercial and, where appropriate, transport records
- ▶ Demonstrated proven financial solvency
- ▶ Demonstrated practical standards of competence or professional qualifications
- ▶ Have appropriate security and safety standards.

Although AEO is not mandatory, the AEO authorisation offers numerous benefits to businesses such as:

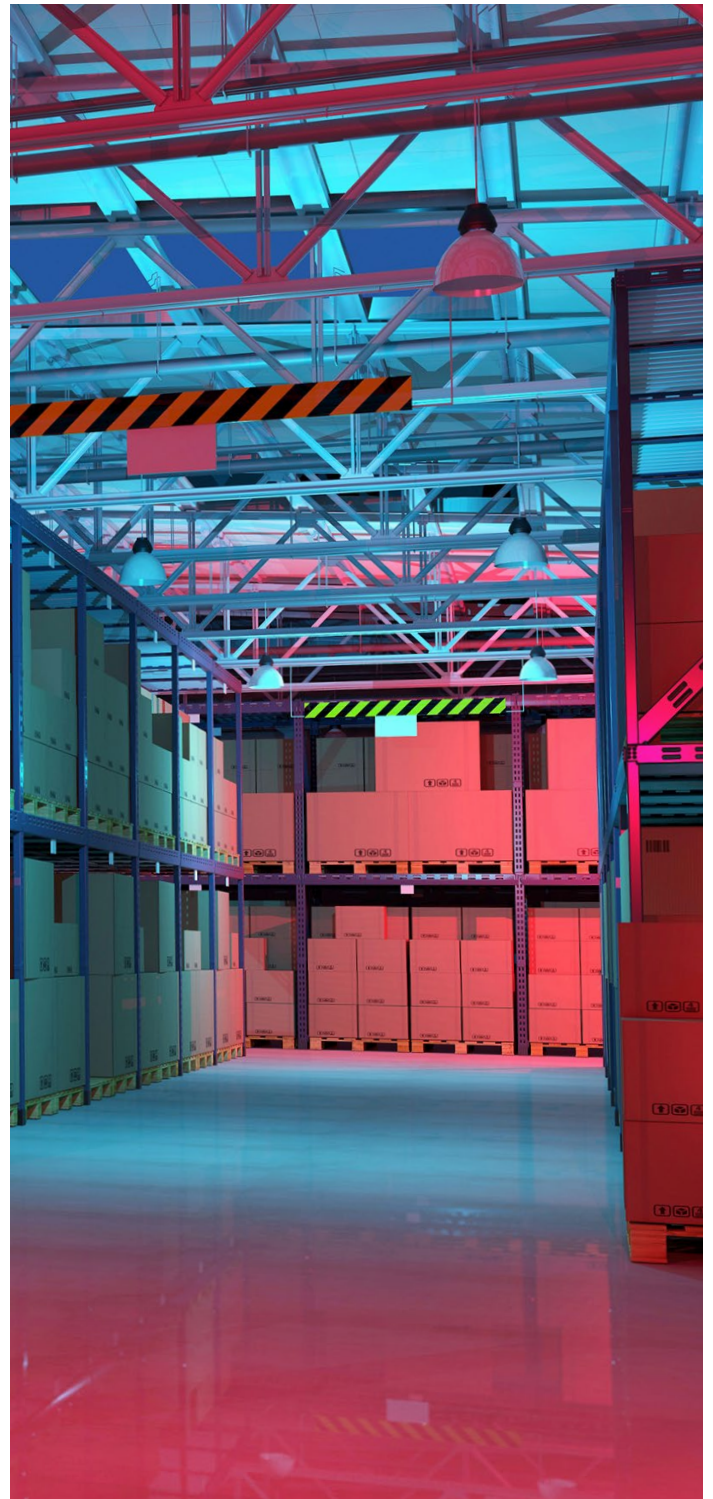
- ▶ International recognition as a safe, compliant business partner by other countries under Joint Customs Mutual Agreements

  - Fewer physical and document-based controls
  - Priority treatment of consignments if selected for control
  - Easier admittance to simplified procedures

  - Faster application process for customs simplifications and authorisations
- ▶ Financial benefits
  - A reduction or waiver of comprehensive guarantees.

Once the AEO authorisation has been granted, your company will be subject to continuous periodic audits by the customs authority. It is, therefore, critical to ensure your business remains AEO compliant after obtaining approval.
